

Owner Waiver & Agreements

Please initial in agreement after each of the following statements...

1. I am the legal owner of the dog named above. ____
2. I hereby waive and release Lise LeLievre from all liability, which my Dog may suffer, including specifically, but not without limitation, any injury or damage whatsoever arising from the Dogs attendance and participation while in Lise's care. ____
3. I hereby agree to indemnify and hold harmless Lise LeLievre from any and all claims, or claims by any member of my family or any other person accompanying me to Rayki's Place, while attending the premises thereof, as a result of any action by any Dog in Lise's care. ____
4. I recognize that the health of my Dog is my responsibility. I hereby represent that my Dog is of good health and has not been ill with any known contagious diseases within the last thirty days. I also represent that all required vaccinations (rabies, bordatella, distemper and parvovirus) are up to date. I will also continue to ensure that the required vaccinations are kept up to date for as long as my Dog attends Rayki's Place. I have and will continue to provide proof of all booster vaccinations to Lise LeLievre. ____
5. I further understand and agree that in accepting my Dog, Lise LeLievre has relied on my representation that my Dog is in good health and has not harmed or shown aggression or threatening behavior towards any person or any other Dog. ____
6. I further understand and agree that Lise LeLievre will not be liable for any problems that might develop with my Dog, including, but not limited to, sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed. ____
7. The hours of operation of Rayki's Place are 7:30 a.m. to 6:00 p.m. Monday to Friday (closed on statutory holidays). I agree that Lise LeLievre retains the right to amend the hours of operation at any time. I agree to drop off and pick up my Dog at

the agreed upon prearranged scheduled times. Holiday Stays are negotiated on an individual basis. ____

8. All fees are due in full (cash or check) on the last scheduled day of each week my dog is in care. All Holiday Stays are to be pre-paid. ____
9. I agree that my Dog may be videotaped and/or photographed and that this media becomes the sole property of Lise LeLievre. ____
10. I understand Lise LeLievre reserves the right to permanently excuse my Dog from her care at anytime for any reason. ____
11. I understand that the inground completely fenced-in and enclosed swimming pool in the backyard presents a small potential risk to my dog. I understand that Lise exercises due diligence in ensuring all dogs are safe and 100% supervised around the pool area. I also understand accidents can happen and I release Lise of all liability should my dog suffer any level of injury (including drowning) related to a pool mishap.
12. I understand that Rayki's Place is not a "registered kennel". I understand that my dog is being cared for in a family home setting. I understand my dog will receive the same (or higher) level of love and attention that he or she would receive in an average home environment. I understand that Lise incorporates the conscious care of my dog into her day-to-day routine.
